Cold Weather Rule Effective Nov. 1 to March 31

To avoid disconnection during the cold weather period, Nov. 1 to March 31, and qualify for the benefits of the Cold Weather Rule, the member must meet and follow the Good Faith Test requirements:

- Inform the cooperative of the member's inability to pay the bill in full;
- ▶ Give sufficient information to allow the cooperative to make a payment agreement;
- ► Enter a level payment plan agreement for past, current and future charges for electric service with arrears paid in equal installments over the next three months. The member and the cooperative may negotiate other payment arrangements mutually agreeable, individualized to the member's situation providing the most appropriate terms, after the member has been informed that he or she has at least three months in which to pay;
- ▶ Apply for federal, state, local or other funds for which the member is eligible:
- ▶ Not obtain electric service by tampering as defined in Section 6.J of our



The Cold Weather Rule ensures you will have electric service for your home during the winter. You must make pay arrangements with Twin Valley Electric to use the Cold Weather Rule.

Rules and Regulations; and

Not default on a payment plan.

The provisions of the Cold Weather Rule establish the disconnection procedures for delinquent accounts of any residential member during the cold weather period. The Cold Weather Rule will be applied when the local National Weather Service office forecasts the temperature to drop below 35 degrees Fahrenheit (the activating temperature) within the following 48-hour period. When the temperature is forecasted to be above the activating temperature for the next 48 hours, the co-op will fulfill the procedures outlined in Section 5 of our Rules and Regulations.

principles—through participation in our democracy.

Co-ops have another advantage. Elected officials and decision-makers across the political spectrum trust us because of the work the electric cooperative family has put into political engagement. When we all get involved, we can make things happen politically and in our local communities.

Our participation in Co-ops Vote helps to ensure that rural issues remain part of the national discussion—and are supported by our elected officials. But Co-ops Vote isn't just for co-ops. It's for co-op members just like you.

Button Up Your Home Before Winter

Old man winter will soon come knocking on your front door. Now is a good time to make sure he won't be accompanied by a draft coming through your home. Use the mild weather now to improve your home's efficiency for greater comfort and less energy waste:

- ▶ Caulk and add weather stripping to doors and windows that leak air.
- Clean your furnace and replace your furnace filter.
- Replace door bottoms and thresholds with ones that have pliable sealing gaskets.
- ▶ Use foam sealant on larger gaps around windows, baseboards, and other places where air may leak out.
- ▶ Make sure your insulation is a foot or foot and a half in your attic or crawl space. If you want to do more than the basics, fall is a great time to call your electric co-op for a home energy audit. For more information on preparing your home for winter, visit SafeElectricity.org.
